and Other Events This Fall

National Pro Bono Week, October is a nationwide celebration, 24-30. by the American Bar promoted Association and intended both to recognize the many hours of free legal services voluntarily contributed by pro bono lawyers throughout the nation and to help recruit more volunteers to expand even further the delivery of pro bono legal services. A formal Pro Bono Week kick-off event for New York, sponsored by the New York State Bar Association, will be held October 22, at the Court of Appeals in Albany.

ProBonoNY committees are sponsoring (or co-sponsoring) Pro Bono Week events again this year, as they did last year. Though operating this year within budgetary restraints that preclude incidental refreshment and related expenses, the committees are nevertheless hosting a variety of celebratory and educational programs. Scheduling preferences and conflicts have resulted in several events occurring before and after the defined calendar week, as well as during the week–but all are inspired by the same enthusiasm for voluntary probono work.

This special issue of the BULLETIN provides brief descriptions, locations, dates and times of Pro Bono Week events and some other fall or early winter events. Judge Fisher will attend as many events a possible. I will also attend as many as I can.

FIFTH DISTRICT COMMITTEE

For the Fifth District Committee, Pro Bono Week provides an opportunity to highlight what programs in the Fifth District do during the year. A galaxy of events is planned throughout the fall to draw attention to the many ways that lawyers, law students, and other members of the legal community meetand can help meet—unmet civil legal services needs.

The Fifth District Committee has been lead sponsor of free two-part, seven-credit CLE programs, completed in late September, for volunteers at the many free Talk-to-a-Lawyer advice and referral clinics in the Syracuse area. On October 26 and November 2, in Syracuse (and in Albany, October 28 and November 4), members of the Committee are participating in planning and presenting a free two-part CLE program for lawyers who represent prisoners in civil rights cases, sponsored by the Pro Bono Committee of the NDNY Federal Court Bar Association.

On October 21, at the Annual Dinner of the Onondaga County Bar Association, the Committee will join the Association in honoring the Association's

2010 Distinguished lawyer, William C. Bergen, recognizing his long-time commitment to pro bono work. Shifting focus to the next generation of lawyers and their teachers, members of the Committee will participate in a panel discussion about pro bono work and a reception for The Syracuse University College of Law community at 5:30 p.m. October 25. On October 28, the Fifth District Committee will continue its program of meeting at locations throughout the district by meeting in Utica prior to the Oneida County Bar Association's screening for the general public of the film, "Adam's Rib."
